1. Season Ticket Entry Fees: The entry fee for the respective Season Ticket is detailed upon the entry system and will be the fee applicable at the date of submission of the entry application form.

2. Entry Policy: Entrants must be at least 15 years of age on the day of the first race for the 10K Series Season Ticket, 17 years of age on the day of the first race for the White Rose Double Season Ticket and 18 years of age on the day of the marathon for the White Rose Treble Season Ticket. Under UK Athletic Rules and Regulations, participants under the age of 18 years must obtain parental consent in order to register and participate in the event.

3. Participants enter the event entirely at their own risk: We shall not be liable for any injury or loss occurring as a result of participation (including, without limitation, resulting from negligence), provided always that nothing in these terms and conditions shall exclude or limit our liability for death or personal injury resulting from the event organiser's negligence or for any other type of liability that cannot be excluded or limited by law.

4. Medical Conditions: It is recommended that you prepare and train for these events. Please consult your doctor for a check-up if you have not exercised for some time. If you have a medical condition it must be detailed on the reverse of your race number provided. Also, we strongly advise that you seek medical advice before participating in this event and that you disclose to those medical advisors the nature of this event.

5. Race Numbers: Race entries are not interchangeable. Entries cannot be assigned, transferred or sold to any third party and is therefore strictly prohibited.

6. Withdrawal from Event: If you are unable to take part in the first event and you do not wish to participate in the other events, we will issue a credit after the event as follows:

- Notification dated 12 weeks or more before the first event of the respective Season Ticket = 50% credit
- Notification dated 6 weeks to 12 weeks before the first event of the respective Season Ticket = 20% credit
- Notification dated less than 6 weeks before the first event of the respective Season Ticket = nil

To receive a credit, you must notify Run For All in writing by email or by post. The date of withdrawal is the date of the email or as postmarked on the envelope.

Please state clearly your full name, registration id, date of birth and the event you are withdrawing from.

7. Transfer of entry (10K's only): If the Participant is unable to participate in one of the chosen 10K Events, he/she may transfer his/her entry (without charge) to another 10K Event organised by the Organiser within the same calendar year. Transfer is on condition that the preferred alternative 10K Event is not closed for entries and the transfer request is received at least seven days prior to the 10K Event in which the participant is unable to participate.

The Participant must notify the Organiser in writing by email, via the online enquiry form on the Website or by post. The date of notification of transfer is the date of the email or two days from

the date of posting. The Participant must state his/her full name, date of birth, name of event and registration ID in all correspondence.

8. No Pets or Dogs: With the exception of registered assistance dogs. The organisers must be advised in advance if an entrant is to be accompanied by an assistance dog.

9. Aided participants: For those participants who are aided around the course, either being pushed or assisted, the guide must also be a registered participant in the event.

10. Wheelchair Entrants: It is strongly recommended that only experienced wheelchair racers attempt the race unaided.

11. For reasons of safety: No entries are permissible from participants on bikes, roller skates, in pushchairs or any kind of mechanical aid. No participants under the age of 15 will be allowed on the course at any time in the 10Ks, under the age of 17 in the half marathons and under the age of 18 in the marathon.

12. General Data Protection Regulation:

12.1 By agreeing to our Terms and Conditions, the Participant agrees to the Organiser storing his/her personal data including name, address, email address, date of birth, telephone numbers, emergency contacts. Includes participants and volunteers and using this information for the purpose of organising the Event in order to send out vital race information. Personal data will not be used for marketing purposes unless marketing consent received.

12.2 In compliance with the General Data Protection Regulation (GDPR) the Participant has the right of access to his/her personal records held on the Organiser's computer. By agreeing to our Terms and Conditions, in order to send the Participant a race pack and fundraising pack (if requested), and produce his/her race results, the Participant authorises the Organiser to release personal details (including his/her full name and address) to the pack provider, charity (if applicable), any official photograph company and timing results company. The Participant also authorises the Organiser to disclose his/her information for medical purposes on the day of the Event. All Run For All third party providers adhere to GDPR and will not use third party data for marketing purposes unless consent has been received.

13. Use of Image: By agreeing to our Terms and Conditions, the Participant consents to the Event being filmed, recorded or exploited by means of television, film, video or some other broadcast or media format and agrees to the use and reproduction of his/her name, likeness, appearance and photograph. All such commercial rights in relation to the same belong entirely to the Organiser and the Participant has no proprietary rights in relation to any film, photograph or other such recorded media. If the Participant does not wish for their image be used in this manner, they should contact the Organiser via the online enquiry form on the Website.

14. Baggage Storage: All personal items and items of clothing may be deposited prior to the race in the designated areas. However, the race organisers and officials do not accept any responsibility whatsoever for the safe keeping or the storage of those items which are stored and deposited entirely at the risk of the participant.

15. First Aid: Adequate First Aid assistance is provided for the duration of the event. There are clearly signed First Aid points both on the course, and at the start/finish area. Please note that Volunteers and Marshals in attendance at the race are not medically trained and will not give medical assistance other than requesting an ambulance or paramedic in the event that medical assistance is required.

16. Collections: Those wishing to make a charity collection on race day will need to obtain prior written authorisation from Run For All Ltd. Please note that we may not be able to grant permission for collections to every request.

17. Race Cancellation: If due to unforeseen circumstances any event in the season ticket is cancelled, our entire liability is as detailed below. We will not cover and further costs and expenses you may incur. The relevant entry fee, unless you indicate otherwise on the entry form,

will be donated to the Jane Tomlinson Appeal. Entrants may be offered a substitute place in an alternative event of equivalent or greater value.

White Rose Double:

Cancellation of one event: refund of 40 per cent of the fee paid at time of entry

White Rose Treble:

Cancellation of a half marathon event: refund of 17.5 per cent

Cancellation of marathon event: refund of 30 per cent

Cancellation of one event: refund of 25 per cent

4 events

Cancellation of one event: refund of 20 per cent

5 events

Cancellation of one event: refund of 15 per cent

18. Change of address: You should notify the organisers of any change of address or contact details.

If you have applied online, you will have been allocated a username and password, which allows you the ability to make this change yourself.

Please note that failure to inform Run For All / Marathon Yorkshire of a change of address 6 weeks before the event, may result in your pack being dispatched to the wrong address and a replacement pack will only be available for collection on race day at a cost of £5.

19. Race mementos: Only finishers will receive a race memento.

20. Mailing Lists: The Participant's name will only be added to the Organiser's mailing list if they agree consent by opting in to receiving marketing. If consent received information will be sent so that the Organiser can keep the Participant informed about other events of the Organiser. By agreeing consent the Participant agrees that such information may also be given to other carefully screened organisations working with the Organiser to deliver the Event. If the Participant does not wish to receive any marketing information he/she can indicate this on the

entry form by not selecting the opt in option. The Participant is able to unsubscribe to these communications at any time.

21. Disclaimer: I accept all conditions of entry set out herein or notified to me prior to the race or displayed at the race or any instruction given to me by the organisers or officials of the race and, I acknowledge that the organisers and officials of the race shall (subject to clause 3 above) have no liability for any loss or damage I may suffer including consequential or indirect loss as a consequence of my participation in the Season Ticket Specials. Run For All and Marathon Yorkshire assumes no liability in respect of the state or condition of the surface upon which the event is held and all participants should ensure that they are satisfied with the state and condition of the surface of the route before commencing the event.

For entrants under 18 years of age please ensure your parent / legal guardian agrees the following:

As the parent or legal guardian of the child named within this application, I have read fully and accept the Terms and Conditions of entry and I hereby give my full consent and approval for my child to participate in the 10K Season Ticket / White Rose Double Season Ticket.
